ORDER:-

In exercise of the powers conferred by clause (c) section 79 of Electricity Supply Act 1948 (Central Act LIV of 1948), the Eastern Power Distribution of Company of Andhra Pradesh Limited, issues the following amendments to the APSEB Service Regulations Part-III issued in B.P.Ms.No.596, dt. 06-06-1978 as adopted by APEPDCL.

AMENDMENT - I

The Sub-Heading Note (2) under Regulation 6 (b) of APSEB Service Regulations Part-III as adopted by APEPDCL shall be replaced and substituted as Note (2) (a).

AMENDMENT - II

Add the following as Note (2) (b) under Regulation 6 (b) of APSEB Service Regulations as adopted by APEPDCL:-

"The qualified & eligible Additional Assistant Engineers shall be considered for conversion as Assistant Engineers subject to the condition that the Additional Assistant Engineers already converted as Assistant Engineers shall not exceed 5% of the cadre strength of Assistant Engineers/Additional Assistant Engineers."
