The promotion ordered above is liable to be reviewed in the light of the judgement in W.P.No 4219 of 1978 and W.P.Nos 2360-91/83 filed by retired officers of the Board and pending in the Supreme Court and also subject to the result of WP.No 3056/91 and W.P.M.P.No.4444 of 2010 in W.P.No.3390 of 2010 in C.C.No.620 of 2010 pending in the High court of Andhra Pradesh.
