In order to expedite and facilitate the implementation of EP-IMRS in all the Section Offices, Sub-Divisions, Divisions, it is hereby proposed to nominate certain nodal officers at Corporate Office.

They should monitor the EP-IMRS daily for at least half an hour and talk to the respective Superintending Engineers, Divisional Engineers, Assistant Divisional Engineers and Assistant Engineers wherever data entry and updation is not taking place regularly. They should also ensure to take necessary action to bring to the notice of the concerned whenever section officers showing lapses in updation of data in EP-IMRS regularly. They should also verify that ADEs, DEs and SEs are effectively monitoring and supervising the section officers use of EP-IMRS. They should bring to the notice of CGM-O&CS and Director/Operation of any problem, lapses and failures in the use of EP-IMRS.
