Part of the section officers in the company are claiming the transportation charges in the work bills against transportation of line materials other than supports from section office to work spot without specific approval from the competent authority.

In this connection a note is circulated to CMD/EPDCL for necessary clarification on the above issue item, where in it is instructed that the concerned operation, Asst.Divisional Engineer has to arrange the transportation on departmental / departmental hired vehicles only from section office to work spot by co-coordinating the vehicles available in their divisions duly admitting the loading and un-loading charges for item of materials which were kept in stores of section office.

Hence all the Divisional Engineers are requested to cause necessary instructions on this matter and do not entertain any claims against transportation of line materials other than supports from section office to work spot in the work bills. All the Superintending Engineers in Operation Circles are also requested incorporate this matter in the respective circle S.S.R's to avoid ambiguity on the item of transportation of line materials other than supports from section office stores or storage point in section to work spot.
