In the reference 13th cited, certain instructions were issued by APTRANSCO that, in-service employees who have acquired Diploma in other than Electrical discipline such as Mechanical, Civil, Telecom, Computer Science etc., shall be considered for appointment by transfer to the post of Sub-Engineer as per eligibility duly counting against the post of Sub-Engineer/Electrical as per the existing practice adopted in case of compassionate appointment: The same was communicated to all the Superintending Engineers/Operation Circles of APEPDCL for taking further necessary action vide reference 14th cited.

2) In the reference 15th cited, Sri K. Srinivasa Varma, who was appointed as Assistant under dependent of deceased quota and working as Assistant/Projects/Corp. Office/VSP, has requested to consider his case for appointment by transfer as Sub-Engineer, as per the instructions issued in the reference 13th & 14th cited, since he has acquired B.Tech/Mechanical prior to his joining in APEPDCL and approved probationer.

3) After careful consideration, the Superintending Engineer/OC/ Visakhapatnam is directed to appoint Sri K. Srinivasa Varma, Assistant/Projects/Corporate Office/VSP as Sub-Engineer by transfer in one of the existing vacancies Sub-Engineer/Electrical in the OC/Visakhapatnam, as per the rules in vogue and report compliance.
