- 1) With reference to the above, the Director of Electrical safety and Chief Electrical Inspector to Government of Andhra Pradesh informed that, the recommendation under Business Reform Action Plan (BRAP)2024 were communicated to this Department has to notify the procedure under Reform Nos.178,179 and 180 of BRAP-2024 i.e., Mandate external/internal electricity installation works typically carried out by a Licensed Professional/Company and qualification of third party carrying-out the electrical wiring installation works.
- 2) Further informed that, the Government of Andhra Pradesh have notified the Regulations for issuing of Licenses to Electrical Contractors and issuing Certificate of Competency and Permits to Supervisors and Wiremen and conditions there for vide G.O.Ms.No.1, Energy, Environment, Science & Technology (Pr-II) dated 2nd January, 1987 under the title “The Andhra Pradesh Electrical Licensing Regulations, 1987” (APELR,1987).
- 3) In this connection the Superintending Engineers/Operation and Executive Engineer/Operation are requested to mandate the recommendations of the BRAP-2024 issued vide reform No.178 and 179 while awarding electrical installations works as detailed in the annexure duly following the provisions laid down in the APELR, 1987 and regulations (50) and (103) of Central Electricity Authority (Measures Relating to Safety and Electric Supply) Regulations 2023 (CEAR,2023). For compliance of reform No.180, the provisions of regulations (3) and (31) of CEAR, 2023 have to be followed to operate and carry out the work on electrical Lines and apparatus duly adapting the precautions required by Consumers, Owners, Occupiers, Electrical contractors, electrical workmen and Suppliers as notified by the Central Electricity Authority vide No.CEA-PS-16/1/1/2021-CEI Division dated 08-06-2023.
- 4) The details of the Reform Nos.178, 179 and 180 of BRAP-2024 and the Actions taken to comply the reforms are annexed.
