The Eastern Power Distribution Company of Andhra Pradesh Limited (*Implementing Agency*) invites sealed bids from eligible bidders for the construction and completion of “Extension of 24Hrs 3 phase supply to sub-station headquarter villages in APEPDCL by Erecting separate 11 kV feeders, VCBs, distribution transformers and connected LT lines on TURNKEY basis” (“the Facilities”) under “Power for All Project” with financial assistance from World Bank. The Bidding process will be conducted under National Competitive (NCB) with “Single-Stage” Two envelope system of procurement as per the World Bank’s guidelines.
2. Bidding documents may be downloaded free of cost from the e-tendering portal www.eprocure.gov.in from 23-09-2019. Interested bidders may obtain further information at the same address. A complete set of bidding documents will be available in the e-tendering portal only and request for bid documents by mail/courier/speed post will not be entertained. Eastern Power Distribution Company of Andhra Pradesh Limited (*Implementing Agency*) will not be responsible for such requests, if any, in the delivery of the documents or non-receipt of the same. ***The bidder would be responsible for ensuring that any addenda available on the e-tendering website is also downloaded and incorporated.***
3. The provisions in the Instruction to Bidders and in the General Conditions of Contract are the provisions of the Bank Standard Bidding Documents: Procurement of Plant Design, Supply, Installation and Commissioning.
4. Bids must be submitted online in the e-tendering portal www.eprocure.gov.in on or before 15:30 hours on 04-11-2019 and will be publicly opened on 04-11-2019 at 16:00 hours, in the presence of the bidders designated representatives who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. Late Bids will be rejected. ***Electronic bidding is the only method of submission of bids and the submission procedures are given in BDS for ITB Clause 22.1.***
5. A pre-bid meeting will be held on 10-10-2019 from 11.00 hours in the Conference Hall, Corporate Office, APEPDCL, P&T Colony, Seethammadhara, Near Gurudwara Junction, Visakhapatnam to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of ‘Instructions to Bidders’ of the bidding document.
