**As per EODB guide lines 168 of the AP State government, on release of INDUSTRIAL Services**


**“All Industrial loads upto 150KVA CMD, shall be released within 7 days where no right of way(ROW) is required. If ROW is required from concerned agencies, the said industrial loads shall be released within 15 days”**

In this connection, the following instructions are issued in respect of release of industrial services to implement the above guide lines.

1. Registration of Industrial loads upto 150KVA shall be closely monitored daily and see that all industrial loads upto 150KVACMD shall be released within 7 days where no right of way is required.
2. If ROW problems are encountered, those are to be resolved immediately by arranging field inspection and see that the said Industrial loads shall be released within 15 days
3. Industrial services are high revenue yielding services and these are to be released within timelines to improve the revenues of the DISCOM.

All the Superintending Engineers/operation and Divisional Engineers/ Operation are instructed to closely monitor this activity and see that both LT &HT Industrial services are released on top priority within the time limit without any deviation.

These instructions shall be implemented with immediate effect.
