

In continuation to the instructions issued under references 1st to 6th cited above and as per the subsequent instructions received from the Industries department, GoAP vide ref.7th cited, the following instructions is hereby issued.

- In light of the requirements of BRAP 2017 under Ease of Doing Business in Andhra Pradesh, an online application has been developed for submission of application, payment and tracking of status without the need for a physical touch point for document submission for obtaining new electricity connection.
- In this regard, all the Superintending Engineers/operation and Divisional Engineers/ Operation are instructed to closely monitor this activity and see that both LT & HT Industrial services are to be registered through **Online mode only viz., MeeSeva, Online registration portal of APEPDCL and Single Desk portal of Industries Department, GoAP.**

These instructions shall be implemented with immediate effect.
