The Petitioner respectfully submits that the Petitioner through this IA is seeking permission from the Hon'ble Commission to procure power from M/s Srivathsa Power Projects Limited beyond the first quarter of FY 2018-19 till the end of FY 2018-19. In this regard, it is submitted that APEPDCL has procured power from the company at the interim tariff approved by APERC vide order dated 26.05.2018 in I.A.No.17 of 2018 in O.P. Nos.60 and 61 of 2017, during the first quarter of FY 2018-19.
2. It is to submit that the MOA (Memorandum of Agreement) to be entered between the Petitioner (APEPDCL) and the Respondent (M/s. Srivathsa) for

procuring power from Respondent is not yet finalized. Once it is finalized, the same will be filed before this Hon'ble Commission for approval after obtaining consent from GoAP. Meanwhile, keeping in view the cheaper cost of Power from M/s. Srivathsa and to avoid local load reliefs due to over loading of 132 KV local lines, it is proposed to continue to procure power from the plant till the end of the FY 2018-19. The tentative price of power from M/s Srivathsa at present works out to Rs. 3.393/kWh.

3. Therefore, the petitioner prays the Hon'ble APERC to issue orders permitting APEPDCL to procure power from M/s Srivathsa at the same fixed cost and variable cost (pass through) as approved by APERC in the order dated 26.05.2018 in IA No. 17 of 2018 in O.P.Nos.60 &61 of 2017.
