

**MOST RESPECTFULLY SHOWETH THE SUBMISSION:**

**The APEPDCL humbly submits the following:**

It is submitted that, the sales to agricultural proposed the ARR and approved in the Tariff Order for FY 2016-17 is based on the historical sales. The actual sales to this category is primarily dependent on the climatic conditions. Due to low rainfall during the year, the water level falling down resulting in more working hours of the pumpsets by individual farmers in most of the areas of the licensee's jurisdiction (within the stipulated 7 Hrs. supply). In spite of strict implementation of agricultural supply timings (7Hrs. duration per day), the agricultural sales volume has been increased considerably. Thus it is



submitted, the licensee have no control over the agricultural sales in the circumstances explained.

Further, the GoAP have directed the DISCOM to extend supply to agriculture in excess of stipulated 7 Hrs. a day to save the crops being dried up at various places in the state. Accordingly, supply was extended to agriculture for additional hours in Srikakulam, East Godavari and West Godavari districts. The consequent additional sales to agriculture has been estimated (11KV feeder wise data obtained and estimated the additional sales) and submitted hereunder.

The overall actual sales to LT Agriculture Consumers during FY 2016-17 is estimated to be 2399.41 MU, which is in excess by 118.25 MU as against the approved quantity of 2281.16 MU.

The major reason for such huge increase is due to extension of supply beyond stipulated 7 Hrs. per day as directed by GoAP in order to save the crops due to acute rainfall and low water table at certain areas of the licensee's jurisdiction. The reasons are submitted below:

- a) Extending supply beyond stipulated 7 Hrs a day to save the crops due to acute rainfall at certain areas in all the eight districts of the licensee's jurisdiction, as per the directions of the GoAP.
- b) Acute lack of rainfall in most of the areas of the licensee's jurisdiction resulting in deep ground water tables.

The licensee have requested the GoAP for providing additional subsidy towards additional sales to agriculture for extending supply beyond stipulated 7 Hrs. a day to save the crops due to acute rainfall at certain areas of the licensee's jurisdiction, as per its directions. The GoAP directed the licensee to submit a petition to Honourable Commission with regard to additional subsidy requirement for the additional sales to agriculture due to extension of additional hours of supply beyond 7 Hrs. seeking approval of the Honourable Commission. The licensee have submitted to the Honourable Commission seeking approval for additional subsidy towards the additional sales to agriculture due to extension of additional hours of supply beyond 7 Hrs. The Honourable Commission have informed the licensee vide Lr.No.APERC/Secy/ Dir (Tariff) / F:28/ 2017, dated 17-01-2017 to file a detailed application with the Honourable Commission in appropriate form in accordance with prescribed procedure with necessary information and data in support of the licensees request.

The actual and approved sales (with excess quantities) to LT agricultural consumers during FY 2016-17 are herewith submitted.

The additional sales were grossed up with actual transmission and distribution losses to get the additional power purchase required to cater to this additional sale to agricultural. The additional subsidy requirement, therefore is the cost of the additional power procured at the rate of the variable cost of the marginal generating station. The computation of the same is shown below:
