Note:

The candidates belong to Visually Handicapped and Hearing Handicapped need not apply for the post and their candidature will not be considered, as the post involves technical or hazardous nature of duties and the Inter Departmental Committee, Women Development, Child Welfare & Disabled Welfare (DW) Department, Government of AP has agreed to interchange the category of Visually Handicapped and Hearing Handicapped to Orthopedically Handicapped for the posts which involve technical or hazardous nature of duties. The Orthopedically Handicapped may apply for the post, if their disability is equal to 40% or above.

I) ELIGIBILITY:-

1) Age:-

Shall not be more than 42 years as on **01-07-2018**. Upper age limit will be relaxed up to 5 years in respect of SC/ST/BC candidates and up to 10 years in respect of P.H. candidates.

In respect of Ex-serviceman – shall be allowed to deduct from his age a period of 3 (three) years in addition to the length of service rendered by him in the armed forces for purposes of the maximum age limit. (The age relaxation for Ex-Servicemen is applicable for those who have been released from Armed Forces other than by way of dismissal or discharge on account of misconduct or inefficiency).

2) Educational Qualifications (as on date of notification):-

A degree in Electrical Engineering/ Electrical & Electronics Engineering of a University in India established or incorporated by or under a Central Act Provincial Act or a State Act or any other qualification recognized as equivalent thereto.

Note:

- (i) If there is any deviation from the above qualifications for posts, the candidate shall produce the equivalent certificate from the authority issuing the qualification certificate viz., Register of the University or Secretary of the Institute for accepting his/her application.
- (ii) Degrees awarded under Distance mode through study centers by other State Universities (beyond A.P. State) are not legally valid.

II) FEE:

- i) Applicants belonging to SC/ST/BC communities of Andhra Pradesh State shall pay an amount of Rs.200/- (Rupees Two Hundred only) towards Application Processing Fee. There is no Examination Fee for the above categories.
- ii) Applicants belonging to PH/Ex-Servicemen shall pay an amount of Rs.200/- (Rupees Two Hundred only) towards Application Processing Fee. There is no Examination Fee for the above categories.
- iii) Applicants belonging to General Category shall pay an amount of Rs.700/- (Rupees Seven Hundred only) towards Application Processing Fee and Examination Fee.
- iv) Applicants belonging to States other than Andhra Pradesh will be considered in General category only and are required to pay the above prescribed fee i.e. Rs.700/- (Rupees Seven Hundred only) towards Application Processing Fee and Examination Fee.

*** Fees once paid will not be refunded.**

III) SELECTION PROCEDURE:-

- i) The selection of candidates for appointment will be made 100% based on Written examination, duly following Rule of Reservation and Spirit of Presidential Order and also other terms notified or modified from time to time.

- ii) Only those candidates, who qualify in the written examination by being ranked high, community-wise will be called for verification of Original Certificates in **1:2** ratio.
- iii) The minimum qualifying marks in the written test for the above selection process shall be as follows:

Note:-

Mere securing minimum qualifying marks doesn't vest any right to a candidate for being called for verification of original certificates and by mere calling the candidate for certificate verification in the ratio 1:2 doesn't vest any right to a candidate for selection.

IV) DETAILS OF WRITTEN EXAMINATION:-

- i) **Syllabus**: The syllabus for the written examination is placed at **Annexure I**.
- ii) **Hall Tickets**: The hall tickets will be placed on the website **seven days** prior to the date of examination. The candidate has to download the Hall ticket from the website only. Hall tickets will not be sent to the candidates by post. No correspondence in this regard will be entertained.
- iii) **Date of examination**:
Tentatively in the month of March-2019. Exact date will be announced separately in website.
- iv) **Examination Centers**: The written examination for recruitment will be held at different centers located in Visakhapatnam only.

V) TERMS AND CONDITIONS OF SERVICE:-

- 1. **Scale of Pay**: Rs.60155-2485-65125-2900-79625-3335-92965
- 2. **Place of posting**: The candidates appointed shall be required to work within the jurisdiction of APEPDCL or wherever necessary.
- 3. The candidate will be governed by the Rules and Regulations applicable or as framed by the APEPDCL and as amended from time to time. The Tripartite Agreement entered into between the APSEB, Govt. of A.P and the Employees Associations is not applicable to these candidates and they shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreement.

VI) EXECUTION OF BOND:-

- (i) The candidates appointed will be required to execute a bond [in Non-Judicial Stamp Paper worth Rs.110/- (Rupees One Hundred and Ten only)] at the time of

- joining, to serve APEPDCL for a minimum period of 5 years after completion of probation period.
- (ii) During the above bond period the candidates will deposit his/her original certificates such as Degree, Date of Birth, and Community etc., with APEPDCL. The certificates so deposited with APEPDCL shall not be returned during the above bond period.
- (iii) The candidate who leaves the APEPDCL service during the probation period shall refund the emoluments received by him/her plus **Rs.60,000/-** (Rupees Sixty Thousand only) by way of liquidated damages.
- (iv) The candidate who leaves APEPDCL service without serving a minimum period of 5 years after completion of probation period shall have to pay a sum of **Rs.1,20,000/-** (Rupees One Lakh Twenty Thousand Only) by way of liquidated damages.

VII) HOW TO APPLY:-

The Applicants have to go through the following guidelines for online submission of application.

How to upload the Application Form:-

To upload the application online, all the candidates have to follow the steps given below:

A) All the candidates are requested to keep the following information ready to fill the application without any difficulty:

- SSC/10th standard certificate details.
- 4th to 10th class study details.
- Qualifying examination details.
- Community certificate details in case of BC/SC/ST candidates.
- PH(OH) Certificate and Percentage of disability.
- Service details of Ex-Service personnel.

B) Instructions for Scanning of Photograph & Signature:-

- Scan the latest photograph of the candidate and upload the same in the space provided in the online application [**scanned image shall be <50 KB in *.JPG format only**].
- Candidate shall make his/her signature on a white paper, scan the same and upload it in the space provided in the online application [**scanned image shall be <30 KB in *.JPG format only**].
- The candidate has to scan his full signature, since the signature is proof of identity, it must be genuine and in full; initials are not sufficient. Signature in CAPITAL LETTERS is not permitted. The signature must be signed only by the candidate and not by any other person.
- The signature will be used to put on the Hall Ticket and wherever necessary. If the candidate's signature on the OMR Sheet, at the time of the examination, does not match with the signature on the Hall Ticket, the candidate will be disqualified.

- C) Open the website: <http://www.apeasternpower.com> and go to Careers/Current Openings and click on the **Apply Online**. You will be directed to the new page with the following options.

 - IV. Print Application Form (only after Submitting Application Form)

Step-I: FEE PAYMENT:

- i. Click on the **Fee Payment** and fill all the required information. Automatically, the amount of fee to be paid will be displayed at the Total amount tab. Then click on the **Initiate Payment**.
- ii. Then it will be directed to the payment gateway. Fill all the required data and complete the payment using your bank/card details.
- iii. Once the payment is completed, a **Payment Reference ID** is generated and note down this number for further process.

Note: The Applicant should pay the prescribed Fee as per the notification in any one of the A.P. Online centers also and obtain Fee paid receipt with **Payment Reference ID** before submission of Application. Applicants can also pay the fee through AP Online portal.

Step-II: SUBMISSION OF APPLICATION:

After the payment of fee, the candidate has to login to website: <http://www.apeasternpower.com> and go to Careers/Current Openings and click on the **Apply Online**. Then click on the **Fill Application Form (only after Fee Payment)** and enter Payment Reference ID, Mobile Number and Date of Birth. Then click on the **Proceed to Fill Application** tab. If the entered details are correct, then the applicant will be directed to online application form. Fill all the required information and click on **Save**, if the applicant wish to fill the remaining fields at later time. If the applicant completes the filling of the application, click on the **Preview/Submit** tab on the screen. After verifying the data, click on the submit tab to submit the application. Then Registration number is generated and also a pdf version of the application will be generated. The candidate can download the pdf of the application and keep it for future purposes.

NOTE:

- (i) **The applicants are required to go through the detailed notification carefully and decide themselves about their eligibility for this recruitment before applying and enter the particulars completely Online.**
- (ii) Before payment of fee, submission of application form, the candidates should carefully ensure his/her eligibility for this notification. No relevant column of the application form should be left blank; otherwise application form will not be accepted.
- (iii) APEPDCL is not responsible for any discrepancy in submitting the application through Online. The applicants are, therefore, advised to strictly follow the instructions in their own interest.

- (iv) Applicant must compulsorily fill-up all relevant fields of application and submit application through website only (online).
 - (v) Incomplete/incorrect application form will be summarily rejected. APEPDCL under any circumstances will not entertain the information, if any, furnished by the candidate subsequently. Applicants should be careful in filling-up of the application form at the time of submission. If any lapse is detected during the scrutiny, the candidature will be rejected even though he/she comes through the final stage of recruitment process or even at a later stage.
 - (vi) Candidates shall submit the application only through **ONLINE** mode well in advance of the last date, to avoid last day rush.
 - (vii) Applications sent other than **ONLINE** mode will not be entertained.
 - (viii) Only applicants willing to serve anywhere in the jurisdiction of APEPDCL should apply.

VIII) General Instructions:

- (i) The candidate should not furnish any false, tampered, fabricated information or suppress any material information while filling up the application form.
- (ii) Candidates called for verification of certificates will be required to furnish documentary proof (Originals) in evidence of the following as and when called for. **“If the particulars furnished in the Online Application Form do not tally with the Original documents produced by the Candidates, his/her candidature will be rejected”**
 1. Age: Proof of age as recorded in SSC certificate or equivalent.
 2. Qualification of degree in Electrical Engineering/ Electrical & Electronics Engineering of a University in India established or incorporated by or under a central Act. Provincial Act or a State Act or any other qualification recognized as equivalent thereto.
 3. Permanent Community Certificate issued by MRO in original or Original Caste Certificate issued by Revenue Officer not less than the rank of MRO issued on or after 01-07-2018 in respect of SC/ST & BC candidates clearly indicating the Sub-Caste and group (**Proforma in Annexure-II**).
 4. Physically Handicapped (i.e. Orthopedically Handicapped) certificate indicating the **minimum 40% of disability** issued by District Medical Board.
 5. Study Certificate or Residence Certificate issued by the Officer of the Revenue Department not below the rank of Tahsildar in independent charge of Mandal as the case may be. (**Proforma in Annexure -III & IV**)
 6. N.O.C from the employer (if already working in any organization).
- (iii) Candidates will be required to appear for written test as and when conducted at their own cost.

- (iv) Admission for written test or calling the qualified candidates in the written test to furnish documentary proof does not confer any right for appointment.
- (v) The decision of the Selection Committee/APEPDCL is final in selection and allotment of candidates.
- (vi) Disqualification:- Conviction in Criminal Cases involving moral turpitude, declared insolvent.
- (vii) Physical Fitness certificate issued by a Medical Officer of the rank not less than that of Civil Surgeon **in the prescribed proforma** to be submitted at the time of joining.
- (viii) The APEPDCL reserves the right to cancel the Notification/Recruitment process at any stage without assigning any reasons.

IX) LOCAL AREA: The DISCOM i.e. Srikakulam/Vizianagaram/ Visakhapatnam/ Rajamahendravaram (East Godavari) and Eluru (West Godavari) Circles/Districts will be regarded as Local area as defined in the Presidential order.

RESERVATION TO LOCAL CANDIDATES: Reservation to the local candidates is applicable as provided in the Rules and as amended from time to time in force on the date of notification. The candidates claiming reservation as Local candidates should obtain the required Study Certificates (from Class-IV to X) or Residence Certificate in the **Proforma in Annexure-III & IV** only for those candidates who have not studied in any Educational Institutions as the case may be.

The relevant certificates may be got ready with authorized signature and kept with the candidates as and when required.

DEFINITION OF LOCAL CANDIDATE:

- (i) **“LOCAL CANDIDATE”** means a candidate for direct recruitment to any post in relation to that Local area where he/she has studied in Educational Institution(s) for not less than **FOUR CONSECUTIVE ACADEMIC YEARS** prior to and including the year in which he/she appeared for S.S.C. or its equivalent examination. If however, he/she has not studied in any Educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her Local area during the above said period.
- (ii) In case the candidate does not fall within the scope of the (i) above it will be considered if he/she has studied for a period of not less than seven years prior to and inclusive of the year in which he/she has studied for the maximum period out of the said period of seven years AND where the period of his/her study in two or more Local areas are equal such Local area where he/she has studied last (in such Local area) will be taken for determining the Local candidature. Similarly, if he/she has not studied during the above said period in any Educational Institution(s) the place of residence during the above period will be taken into consideration and Local candidature determine with reference to the maximum period of residence or in the case of equal period where he/she has resided last.
- (iii) If the claim of Local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution(s) where he/she has

studied during the said 4/7 year period. If, however, it is based on residence, a certificate should be obtained from an officer of the Revenue Department not below the rank of a Tahsildhar in independent charge of a Mandal. (**Proforma in Annexure- III & IV**)

- (iv) If, however, a candidate has resided in more than one Mandal during the relevant 4/7 years period but within the same District or Zone as the case may be, separate certificates from the Tahsildhars exercising jurisdiction have to be obtained in respect of different areas.

NOTE:

- a. Single certificate, whether of Study or Residence would suffice for enabling the candidate to apply as a “**LOCAL CANDIDATE**”.
- b. **Residence Certificate** will not be accepted, if a candidate has studied in any Educational Institution up to S.S.C or equivalent examination, such candidates have to produce **Study Certificates invariably**.
- c. The following percentage of reservation of posts in respect of local candidates shall be followed while making direct recruitment in APEPDCL for following the spirit of Presidential Order.

“60% of the posts to be filled by Direct Recruitment shall be reserved for Local Candidates in respect of Assistant Engineer/El. in Engineering Service in APEPDCL as unit which was declared as local area for the said post. **The remaining 40% of the posts shall be filled by open competition wherein local and non local candidates can compete.**”

ANNEXURE-I

SYLLABUS FOR THE COMPETITIVE TEST FOR THE RECRUITMENT OF ASSISTANT ENGINEERS

1. **ELECTRICAL CIRCUITS AND NETWORKS:** Kirchhoff's laws, mesh and node analysis, network, theorems, sinusoidal steady state analysis of single phase and three phase circuits, resonance, transient response of RL, RC, RLC circuits for different inputs, two-port networks, elements of two element network synthesis.
2. **CONTROL SYSTEMS:** Modelling of physical systems, Block diagrams and signal flow graphs, Time and frequency domain analysis, Steady state errors, Routh's criterion, Nyquist and Bode plots, compensation, root loci, elementary ideas of state variable analysis, control system components.
3. **MEASUREMENTS AND INSTRUMENTATION:** SI units, measurement of current, voltage, power-factor and energy. Measurement of resistance inductance capacitance and frequency-bridge methods, transducers and their applications to the measurement of non-electrical quantities like temperature, pressure, strain, displacement etc., cathode ray oscilloscope.
4. **ANALOG AND DIGITAL ELECTRONICS:** Characteristics of diodes, BJT, FET, SCR, Amplifier biasing, equivalent circuits, frequency response, feedback amplifiers power amplifiers, oscillators, operational amplifiers and applications, wave shaping circuits, multivibrators flip-flops, universal gates, combinational circuits, A/D and D/A converters.
5. **ELECTRICAL MACHINES AND POWER ELECTRONIC DRIVES:** Single Phase Transformer, equivalent circuit, tests, regulation and efficiency, three phase transformer connections parallel operation, auto transformer, principle of energy conversion, windings of rotating machines, DC generators and motors, characteristics, starting and speed control, three phase induction motors performance characteristics, starting and speed control, single phase induction motors, synchronous generators, performance, regulation parallel operation, synchronous motors, starting characteristics and applications, synchronous condensers, fractional horse power motors, permanent magnet and stepper motors Characteristics of Power electronic devices, phase control, bridge converters, choppers and inverters, basic concepts of adjustable speed drives.
6. **POWER SYSTEMS:** Electrical power generation, thermal, hydro, nuclear: transmission line parameters; steady state performance of overhead transmission lines and cables, surge propagation, distribution systems, insulators, bundle conductors, corona, and radio interference effects; per-unit quantities; bus admittance and impedance matrices: load flow: voltage control and power factor correction; economic operation, symmetrical components, analysis of symmetrical and unsymmetrical faults; principles of over current, differential and distance protections, circuit breakers, concept of system stability – swing curves and equal area criterion.
